TEES: Apply at the 1.25 lb. rate (5.7 lbs. of BEST[®] SHORT-KUT[®] 22 22-5-10 with GAL-Xe^{ONE}[®] and X-COTE[®]).

FAIRWAYS: Apply at the 0.75 or 1.0 lb. rate per 1000 sq. ft. depending on response and longevity desired.

NOTE: Liquid measuring cups are very close in estimating the weight of dry granular fertilizers. Example: an 8 oz. (1 cup) measuring cup holds approximately 8 oz. (1/2 lb.) of dry granular fertilizer.
