DIRECTIONS

D-BOP™ is a temporary, aerosol foam marker that can be conveniently applied from a standard marking paint applicator which accepts a standard UMA tip. Applied foam markers are non-phytotoxic to turfgrass and are non-staining when applied to hard surfaces. Depending on wind speed and humidity, applied foam will last between 4-6 hours if left undisturbed. To hasten the degradation of the applied foam markers, overhead irrigation will disperse the foam more rapidly.

INSTRUCTIONS FOR USE:

1. For best results, use when can temperature is between 40°F and 90°F (4°C and 32°C).
2. Shake can well for at least one minute before use and occasionally during use.
3. Invert can (or load into appropriate marking paint wand) and hold 2 to 4 inches (5 to 10cm) above surface to be marked. Press sprayhead to the side to actuate and dispel aerosol foam.
4. Apply foam in a circular motion to allow foam to stack on itself until desired shape and size for marker bead is achieved.
5. If clogging develops, turn sprayhead 1/4 turn or remove and clean sprayhead slot. DO NOT stick pin or other objects into can opening. With can and sprayhead pointed away from you, reinsert sprayhead with a gentle twisting motion.
6. To clear sprayhead for future use, turn can right side up and spray for 3 seconds.
